All racers, new and returning, under the age of 18 must complete the following forms PRE-SEASON: Minors Assumption of Risk, Minor Release and Waiver of Liability and Indemnity Agreement, Minor Competitor Eligibility Notification and **Parental Consent, Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement and Minor's Assumption of Risk and Release and Waiver of Liability**. Additional forms may be required – please see below.

The youth driver packet must be completed by parents and driver before any racing takes place. We must have on file proof of age prior to any racing. Copies of birth certificate, driver's license or passport are acceptable.

The form titled **PARENTAL CONSENT, RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT** and **MINOR'S ASSUMPTION OF RISK AND RELEASE AND WAIVER OF LIABILITY** (PAGES 8 & 9) can now be completed **ONCE PRE-SEASON. YOU MUST LIST ALL EVENTS YOU WILL BE ATTENDING** in the section titled "DESCRIPTION AND LOCATION OF EVENT(S)." Please list the site locations and race dates.

At any time a parent/guardian cannot attend an event with the racer the Power of Attorney (POA) form (PAGE 7) must be completed and submitted on site to the office staff. Faxing this form is not permitted. The POA must be notarized and have original signatures. Parents/guardians must designate someone over the age of 18. A racer under 18 will not be permitted to compete if the POA is not provided when parents do not accompany them.

Competitors age 14+ may advance into upper age classes providing the racer and parent comply with all requirements of the EASTERN SNOCROSS TOUR Advancement Procedure. The driver must have raced in at least one entire event in his/her age appropriate class and then the parent and driver must petition EASTERN SNOCROSS TOUR citing the driver's qualifications prior to registering for a higher class. The race director and committee will make advancement decisions.

EASTERN SNOCROSS TOUR reserves the right to move any competitor down to lower classes should EASTERN SNOCROSS TOUR feel the driver is not participating in a safe manner.

I/WE HEREBY RELEASE, WAIVE, COVENANT NOT TO SUE AND DISCHARGE the promoter, participants, racing association, sanctioning organization or any subdivision thereof, track operator, track owner, officials, vehicle owners, drivers, pit crews, any persons in any restricted area, promoters, sponsors, advertisers, owners, lessees of premises used to conduct the event and each of them, their officers and employees, all for the purposes therein referred to as "Releases" from all liability to the undersigned, my/our personal representatives, assigns, heirs and next of kin for any and all loss or damage and any claim or any demand on account of any injury to the participant included, but not limited to, death whether caused by the negligence of the "Releases" or otherwise while the minor is in or upon the restricted area and/or competing, officiating in, observing, working for or for any purpose in participating in the event.

I/we will inform and instruct the said minor participant that upon entering any restricted area the minor must continuously thereafter inspect such restricted area and all portions thereof which the minor enters and with which lie comes in contact and I/we further warrant that the minors entry upon such restricted area or areas and his participation, if any, in the event constitutes an acknowledgement that he (minor) has inspected such restricted area and that he finds and accepts the same as being safe and reasonably suited for the purposes of his use, and he further agrees and warrants that if, at any time, he is in or about restricted areas and if he feels anything is unsafe, he will immediately advise the officials of such and will leave the restricted areas.

MINOR COMPETITOR ELIGIBILITY NOTIFICATION

Eastern Snocross Tour ADVANCEMENT POLICY

EFFECTIVE 2019-20 SEASON

- Drivers who competed in Semi Pro Open AND Pro Stock (Hybrid Division) for the 2019-2020 season must compete in those divisions for the 2008-09 Season, **UNLESS** they were advanced to full pro division. The driver may also elect to compete solely in the Pro Division.
- The top 2 drivers from Semi Pro Stock & Open divisions will advance to the full Pro division for the 2008-09 Season.
- Once competing at the Pro level drivers will remain in the division unless the driver poses a danger to themselves or other competitors.
- Full Semi Pro Drivers (not hybrid riders) wishing to race Pro Stock class may do so in addition to the Semi Pro classes, but after 5 podiums (top 5 placements in the Pro Stock) will be forced to move into the Hybrid division (Semi Pro Open and Pro Stock). This does not apply to the current hybrid riders.
- Minor Sport drivers may not advance to Semi Pro without completing advancement paperwork.
- Top 5 in points in the sport division will have an opportunity to run one Semi Pro Stock class in addition to their sport class, but after 5 podiums (top 5 placements in the Semi Pro class) will be forced to move up to the Semi Pro division.
- A new Junior racer must compete in at least one entire event in an age appropriate division before becoming eligible for advancement.
- A Junior racer who has advanced to the Sport division may also race in Junior 16 – 17 class. They may not race in Junior 14 – 15 if they have advanced to the Sport division. If a Junior racer has three top 3 finishes in the Sport Division the driver must move up to the Sport division and they may not continue in any Junior classes.
- At any time, the Race director reserves the right to advance or demote a driver at his/her discretion.



Before you can advance a class the EASTERN SNOCROSS TOUR Race Officials must approve you. You must sign up for the race before you send in this form. EASTERN SNOCROSS TOUR will evaluate your performance in your age appropriate class at the race you have entered. If you are approved by the EASTERN SNOCROSS TOUR Race Officials for advancement you will be eligible to compete in that class at the next event. Please complete this form, including signatures of driver & parent, and mail or fax it. It must be received by EASTERN SNOCROSS TOUR the Tuesday prior to the race.
