Should the transponder be determined to not be in proper working condition, the driver will be notified and by signing below, the driver agrees to pay Eastern Snocross Tour \$240.00 for the replacement of the transponder. If a credit card was used for the security deposit, the driver agrees to have his credit card charged \$240.00. Failure to comply with this will disqualify the driver from entering any other Eastern Snocross Tour sanctioned event and could cause a loss of membership.
